ELIGIBILITY CRITERIA

Applicant will be required to submit the following documents along with their application form:

1. Domicile of a district in NWFP Province.
2. In case the father/guardian of students is a salaried person, an employer's certificate regarding the guardian/father's annual take-home salary.
3. Electricity bills of the principal residence of the father/guardian.
4. If the annual take-home salary in case of salaried person or electricity bill in case of non-salaried person does not exceed Rs. 300,000/- per annum and Rs. 50,000/- per annum respectively, the students will be declared eligible.
5. Scholarship will be awarded to the most needy applicant amongst the eligible applicants.
