- 1.2. At any time prior to the deadline for submission of bids, a modification in bidding document in the form of an addendum can be issued in response to a clarification requested by a respective bidder(s) or even whenever the Client considers it beneficial to issue such a clarification and/or amendment to all bidder(s). The clarification/amendment issued (in general) shall be placed on the GIK INSTITUTE web site for the intimation to all the prospective bidder(s).
Bidder(s) are required to submit their bid(s), which will bear words "CONFIDENTIAL" and for **TENDER NO. GIKI/PD/WORKS-837/21** as per Tender Notice.
- 1.3. The Client reserves the right to increase or decrease the quantities or may cancel the tender without assigning any reason thereof.
- 1.4. The Client reserves the right to have the work done inspected by its own representative, or by 3rd party at its own cost (if required).
- 1.5. It must be indicated in the offer that the Bid fully conforms to Technical Specifications and Terms and Conditions of the Tender.
- 1.6. The Client reserves the right to accept or reject any bid and to annul the bidding process and reject all the bids at any time prior to award of Contract without thereby incurring any liability to the affected bidder(s) or any obligation there under. However, GIK Institute shall upon request communicate to any bidder(s) who submitted a bid, the grounds for its rejection, but it is not required to justify those grounds.

- 2.2. Prices must be quoted in Pakistani currency inclusive of all taxes and duties, indicating unit price and total bid prices. GST must be quoted separately along with copy of GST Certificate. Bids offering prices in foreign currency will be rejected. Conditional bid / bid having any price adjustment formula will be rejected.
- 2.3. Prices must be quoted including all charges like handling, loading, transportation and unloading, Octroi and Zila Tax etc. for delivery of material at Client's stores located at **required delivery location.**
- 2.4. Quoted prices will be valid for 90 days from the opening date of the **Bid.**
- 2.5. Discount (if any) shall only be entertained on Schedule of Requirement of Bidding Document (Financial Proposal). If the discount is mentioned elsewhere in the bid, the same shall not be entertained.
- 2.6. Tender submitted without Tender Fee Rs 2,000/- (in shape of Pay Order/Demand Draft) & earnest money CDR should be rejected at the time of opening of Tender.

ANNEXURE-B

Erection & Construction of Tensile Car Park Shed

Scope of Work

Size for one CAR PARK = 8'x10'X18' or as per standard

All materials shall be free from injurious defects and shall have a smooth finish/surface.

Foundation:

Providing and laying in position cement concrete 1:2:4 for the erection of supporting structure in suitable size of execution including the cost of side channel fixing as shuttering and base plate with nuts and bolts as per standard (**design attached below**).

The foundation shall be strong enough to sustain the supporting structure/roof top subjected to high wind pressure. Complete in all respect.

Supporting Structure:

Supply, fabrication & erection of hollow MS structure which includes columns, rafters, purlins, connecting plates, gusset plate, base plate, anchor bolt etc with two or more coats of enamel paint of approved color over two coats of zinc chromate primer to give proper finish complete in all aspects as a turnkey project and as per design.

Note: - Connecting plates, gusset plate, base plate, anchor bolts to be paid as per actual.

Roof top:

The roof top shall be made of Epoxy Glass Fiber reinforced composite, thickness as per standard, conforming to the latest engineering practice, to be measure net and no allowance shall be made for overlaps. Supply & fixing of Aluminum extrusions for clamping epoxy glass fiber to surface of steel structure with bolts for fixing, bitumen or silicon washers to ensure water tightness Supply & fixing of Galvanized accessories which includes all hardware complete in all respect. Detailed specification, fixing details as per manufacturer Test certificate, sample to be provided before start of work and warranty certificate for epoxy glass fiber reinforced composite from manufacturer to be provided at completion of work.
